## In the House

The Illinois Coalition Against Sexual Assault (ICASA), the statewide association of 30 community-based rape crisis centers, takes the following positions on legislation impacting sexual assault victims.

### **Support**

#### \$20 Million in GRF funding for Rape Crisis Services.

Dedicate \$20 million in General Revenue funding for sexual assault services. A \$12 million increase would sustain rape crisis services in Illinois by offsetting the \$9 million VOCA funding deficit and addressing rising workforce and inflation costs. This investment amounts to about \$900 per survivor served by ICASA centers.

**HB 2755:** Creates victims' rights parity with the Organized Retail Theft law, and provides for vacation of any (rather than only prostitution) convictions for offenses committed as a result of having been a victim of human trafficking.

Status: Rule 19(a) / Re-referred to Rules Committee

**SB 1907:** Requires each public institution of higher education make emergency contraception available for purchase through at least one wellness kiosk located on each campus under its jurisdiction. The products must be sold in the manufacturer's original clearly labeled, unbroken, tamper-proof packaging. It must not be expired, must be properly stored, and must be available at a reduced price.

**HB 2280:** Requires health care professionals licensed by DFPR who have continuing education requirements to complete cultural competency training, which include best practices for providing affirming care to people with disabilities, immigrants, people who are intersex, people living with HIV, and people of diverse sexual orientations and gender identities.

**HB 2158:** The State, school districts, and units of local government may only expend funds at hotels and motels certified by the Department of Human Services as providing human trafficking recognition training to their employees.

## Oppose Bills that Allow Parole for Offenders Sentenced to Natural Life in Prison for Convictions of Multiple Class X Sex Offenses

HB 3373: All persons serving terms of imprisonment, including natural life terms for multiple Class X Sex Offenses, would be eligible for "earned reentry" if they have served at least 20 consecutive years (once fully implemented). The Prisoner Review Board will determine whether earned reentry should be granted after a hearing. The incarcerated person may petition every two years and must be provided a hearing. Applies retroactively. Provides for victim notice and participation in the hearings. For victims of Class X Sex Offenses, this change from a life sentence to allowing release breaks the promise the criminal justice system made that the offender would never be released, which may result in re-traumatization and a feeling of lost safety. Also, victims may feel a need to re-engage with the offender each time a hearing is scheduled, which could be every two years.

### In the Senate

SB 333: ICASA's Priority Bill. Amends the mandate that hospitals and healthcare providers treating crime victims must notify law enforcement as soon as treatment permits to allow survivors of sexual assault to choose to delay notification up to 24 hours and to control what information is shared.

Status: Third Reading

**HB 1397:** Amends the Criminal Code to provide that criminal sexual assault and criminal sexual abuse include an act of sexual penetration or conduct using "coercive control," which is "a direct or implied threat of danger, or retribution sufficient to coerce a reasonable person of ordinary susceptibilities to perform an act that otherwise would not have been performed, or acquiesce in an act to which one otherwise would not have submitted."

**HB 2607:** Creates a rebuttable presumption that a child victim under 13 years of age shall testify outside the courtroom by means of a closed-circuit television (CCT). This presumption may be overcome if the defendant proves by clear and convincing evidence that the child victim will not suffer severe emotional distress. Court must make a finding that testimony by means of CCT does not prejudice the defendant.

**HB 2231:** Removes liability shield from the Transportation Network Providers Act, which provides Transportation Network Companies are not common carriers, contract carriers or motor carriers. Makes companies like Lyft and Uber legally responsible for actions of their drivers, similar to taxicab companies. In *Jane Doe v. Lyft*, a passenger who was sexually assaulted by a driver struggled to sue Lyft.

HB 2123 & SB 1392: Creates the Digital Forgeries Act. An individual depicted in a digital forgery has a cause of action against any person who, without the consent of the depicted individual, knowingly distributes a digital forgery, or creates or solicits the creation of a digital forgery with intent to distribute: (1) in order to harass, extort, threaten, or cause physical, emotional, reputational, or economic harm to the individual falsely depicted; (2) with reckless disregard for whether such a creation, distribution, reproduction, or manipulation will cause such harm; or (3) in order to incite violence or interfere with an official proceeding.
